Sub : Filling up of the post of Deputy Director in the Board for Industrial and Financial Reconstruction (BIFR) on deputation /reverse deputation basis from the officers of Ministries/Departments of the Govt. of India/Nationalised Banks/ Public Financial Institutions/Central Public Sector Undertakings.

Applications are invited from eligible & willing officers from (A) Ministries/Departments of the Govt. of India and its attached/subordinate offices and (B) Nationalized Banks/Public Financial Institutions/Central Public Sector Undertakings, to fill up 1 (one) post of Deputy Director in BIFR on deputation/reverse deputation basis. The post carries scale of Pay Band-3(Rs. 15600-39100) + Grade Pay Rs.6600. The terms and conditions of deputation will be governed by the provisions of DOP&T O.M No.2/29/91-Estt. (Pay-II) dated 05.01.1994, as amended from time to time. The deputation will be initially for a period of one year, extendable upto 5 years.

(i) Officers holding analogous posts in the Ministries/Departments of the Central Govt. and the officers of equivalent rank in their attached/subordinate offices with a minimum experience of 5 years of handling work relating to industrial project finance & industrial rehabilitation ;

(ii) Officers holding the post of AGM or equivalent in Nationalized Banks/Public Financial Institutions/Central Public Sector Undertakings with a minimum experience of 5 years of working in industrial project finance and industrial rehabilitation.

The officers having any sector specific specialization should mention it clearly in their applications.
